5. In addition to the fees prescribed in clause no 4 above, the Company will reimburse you for all out of pocket expenses necessarily incurred in carrying out your duties in accordance with the Company's expenses policy as amended from time to time.

External Advice:

6. In order to enable you to carry out duties effectively you mat, after consulting the Managing Director, be entitled to seek external independent advice at the company's expenses.

In the event, that you are requested to serve on one or more of the Board committees this will be covered in a separate communication setting out relevant committee's terms of reference.

Induction:

Immediately after the date of Appointment, the Company will provide a comprehensive induction to help you build up an understanding of the Company, its business and the markets in which it operates. The Company will arrange for visits and meeting with senior and middle management, the Company's auditors and shall provide copies of the code of conducts and policies as adopted from time to time.
